# 2018 OHNS Coding and Reimbursement Guide

## INTRODUCTION

Coverage, coding and payment for medical procedures and devices can be complicated and confusing. This guide was developed to assist with Medicare reporting and reimbursement when performing procedures in which the OHNS products and devices may be used.

## COVERAGE

Medicare carriers may issue Local Coverage Decisions (LCDs) listing criteria that must be met prior to coverage. Physicians are urged to review these policies (<http://www.cms.hhs.gov/mcd/search.asp?>) and contact their carrier's medical director (<https://www.cms.gov/apps/contacts/>) or commercial insurers to determine if a procedure is covered.

## CODING

In the following pages, Cook Medical has suggested codes to be reported by physicians and facilities when reporting services in which our devices are used. It is ultimately up to the billing entity to decide the most appropriate code(s) to report for their services.

### Unlisted Procedure Codes

CPT coding convention requires that you “[S]elect the name of the procedure or service that accurately identifies the service performed. Do not select a CPT code that merely approximates the service provided. If no such specific code exists, then report the service using the appropriate unlisted procedure or service code.”<sup>4</sup> As of 2018, a CPT code does not exist that accurately describes the sialendoscopy procedure. As such, the unlisted procedure code 42699-Unlisted procedure, salivary glands or ducts-should be reported to describe this procedure. We encourage facilities to contact their patients’ insurance plans for guidance.
