Coverage, coding, and payment for medical procedures and devices can be confusing. This guide was developed to assist with Medicare reporting and reimbursement for use of the Word catheter in the treatment of a Bartholin gland cyst or abscess. Coverage

Medicare carriers may issue local coverage decisions (LCDs) listing criteria that must be met prior to coverage. Coding

The Current Procedural Terminology (CPT®) code used to describe incision and drainage of a Bartholin cyst and placement of a Word catheter is as follows:

56420 - Incision and drainage of Bartholin's gland abscess*

*CPT code 56420 includes the placement and removal of the Word catheter.
