### Coverage

Medicare carriers may issue local coverage decisions (LCDs) listing criteria that must be met prior to coverage. Physicians are urged to review these policies ([www.cms.gov/medicare-coverage-database/search.aspx](http://www.cms.gov/medicare-coverage-database/search.aspx)) and encouraged to contact their local carrier medical directors ([www.cms.hhs.gov/apps/contacts](http://www.cms.hhs.gov/apps/contacts)) or commercial insurers to determine if a procedure is covered.

### Coding

#### Transcatheter Biopsy

37200	Transcatheter biopsy
75970	Transcatheter biopsy, radiological supervision and interpretation

#### Catheter Placement

36011	Selective catheter placement, venous system; first order branch (eg, renal vein, jugular vein)

#### Venography

75831	Venography, renal, unilateral, selective, radiological supervision and interpretation
75889	Hepatic venography, wedged or free, with hemodynamic evaluation, radiological supervision and interpretation
75891	Hepatic venography, wedged or free, without hemodynamic evaluation, radiological supervision and interpretation

**NOTE:** Diagnostic venography performed at a separate setting from an interventional procedure is separately reported.<sup>1</sup>

**NOTE:** Diagnostic venography performed at the time of an interventional procedure is NOT separately reportable if it is specifically included in the interventional code descriptor.<sup>1</sup>
